Buy More Save More – Terms and Conditions

- All customers, who are shopping at the outlets operated and maintained by Delhi Duty Free Store (DDFS) and other Duty Free outlets as listed/detailed in the paragraph below at Terminal 3 International, of IGI Airport are eligible to participate in the Promotion.
- 2. Participation in this Promotion is applicable solely on purchase at Terminal 3 International at the participating duty-free outlets as specified below:

- 3. Delhi Airport Buy More Save More (the 'Promotional Discount') includes issuance of discount code on net amount purchased as per slabs mentioned in the table below. This discount code shall be printed on the invoice issued to the customer. Validity of the discount code is 4 hours from the time of issue and it can only be redeemed in the Terminal-of-Issue (whether Arrival or Departure). The Discount code can be redeemed on the next purchase. The details of net amount purchase and value of discount coupon is detailed as under:

* Maximum discount capped at ₹ 3,000 at Terminal 3I Arrivals per bill

- Basis qualifying the Net Bill value slab, a coupon code will be issued on the invoice that can be redeemed on next purchase. Such coupon code can be redeemed within 4 hours of issue at the Terminal-of-Issue (whether Arrival or Departure);
- Discount will be calculated on net value of Bill.
- Once a promo coupon has been redeemed then both the transactions related to issuance and redemption of coupon cannot be cancelled or refunded.
- Generated coupons may not be redeemed if issuance transaction is refunded or cancelled.

Key Conditions:

- 1. An Individual is allowed to make multiple numbers of transactions in a single day.
- 2. Offer is valid in all the categories sold from the participating outlets.
- 3. Coupon is redeemable on any of the passport (single passport/group passport) on which the coupon code was issued;
