WHEREAS, vide order dated 06.05.2021 of Hon'ble High Court in Public Interest Litigation Writ No. 1172/2021, it has been directed to ensure that no persons are permitted entry into the state unless they possess a negative certificate obtained within 72 hours from the time they seek entry into the state

AND WHEREAS, an order No.37/19/2020/L&O/MAG/4726 dated 08.05.2021 under Section 144 of the Criminal Procedure Code has been issued wherein inter-state movement for tourists from 10th May onwards has been prohibited except for people who are residents of Goa or are entering Goa for work, or who have with them the full vaccination certificate or Covid negative test report for a test done within 72 hours of entry in Goa;

NOW THEREFORE, in exercise of the powers conferred under Section 26, 30(2)(v), and 33 of the Disaster Management Act, 2005, and for the implementation of the directions of the Hon'ble High Court and the order issued u/s 144 of the CrPC, the undersigned hereby directs you that any person coming from outside Goa into the South Goa district, shall be checked for the full vaccination certificate or Covid negative test report for a test done within 72 hours of entry in Goa.

However, the following categories of people are exempted from the above requirement:

- 1. Residents of Goa, on production of proof of residence,
- 2. Persons entering in Goa for work, on production of workID proof/ letter from employer,
- 3. Persons entering in Goa for a medical emergency, on production of proof or coming in ambulance.

Failure to comply with this Order shall be a violation of the provisions of the Disaster Management Act, 2005 and shall attract penal action as per law.

ORDER

U/S 144 OF CRIMINAL PROCEDURE CODE, 1973

WHEREAS, a surge in COVID-19 cases is being witnessed in Goa and other parts of the country, and the situation might further aggravate due to public gatherings and active interactions along with high positivity rate;

AND WHEREAS, in order to contain the spread of the said pandemic, certain measures were undertaken and more are required to prevent the further spread of the disease;

AND WHEREAS in my considered opinion, there are sufficient grounds for proceeding under sub section (1) of section 144 of Code of Criminal Procedure, 1973 to take preventive steps to contain the spread of Virus by restricting public gatherings and activities;

AND WHEREAS, I am satisfied that the circumstances do not permit the individual serving of orders, in due time, of the notices individually upon the persons against whom this order is directed and therefore, under the powers vested in me under sub section (2) of Section 144 of the Code of Criminal Procedure, 1973, I hereby pass the order ex-parte;

NOW, THEREFORE, I, Ruchika Katyal, IAS, District Magistrate, South Goa District, in exercise of the powers conferred upon me by Section 144 of the Code of Criminal Procedure 1973, direct that the following

activities/establishment/facilities/events shall be prohibited or restricted in the district of South Goa, from 7 am on 9 May 2021 to 7 am on 24 May 2021:

- 1. The following activities/establishment/facilities/events shall remain closed:
 - a. casinos.
 - b. bars.
 - c. restaurants, (however restaurant kitchens will be allowed to provide home delivery/takeaways),
 - d. shops, (except as at the point no. 3, below),
 - e. sports complex/auditoriums/community halls or similar places,
 - f. river cruises/waterparks/entertainment parks,
 - g. gym/spa/massage parlours/saloon,
 - h. cinema halls, theatres, multiplexes, entertainment zones within Shopping malls.
 - i. swimming pool,
 - j. schools, colleges, educational and coaching institutions, except for examinations of college students,
 - k. religious places for the public, however the custodian of such establishments may carry out regular activities.
 - I. weekly market, fish market and Municipal/Panchayat market;
- 2. The following activities will be prohibited:
 - a) social/political/sports/entertainment/academic/cultural functions, marriages, and other congregations, (except for events with the permission of the government). However, Cremation with 20 people or less will be permitted,
 - b) gathering of five or more persons at public places, except for official functions or with permission from DM/SDM,
 - c) inter-state movement for tourists from 10th May onwards (people who are residents of Goa or are entering Goa for work, or who have with them the full vaccination certificate or Covid negative test report for a test done a maximum of 72 hours prior to entering in Goa will be permitted),
 - d) use of buses except for people going for duty purpose and medical emergencies, with a maximum capacity of 50%;
- 3. The following shall be exceptions to the above restrictions/prohibitions at para 1& 2:
 - a) shops selling medicines/drugs and related activities.

- shops selling groceries/eatables, animal fodder, Public Distribution System and such outlets, standalone liquor shops (for take away only) may remain open from 7 am to 1 pm (home delivery of all these items, except liquor, will be allowed anytime)
- Banks, insurance, custom clearance, ATMs, microfinance institutions, etc.,
- d) all medical and health services/institutions (including AYUSH and Veterinary Hospitals, and laboratories) to remain functionals,
- e) Operations of homes for children/disabled/mentally challenged/senior citizens/destitutes/women/widows, etc.
- f) Observation homes, after care homes and places of safety for juveniles, etc.,
- g) all facilities in the supply chain of essential goods, whether involved in wholesale or retail of such goods through local stores, large brick and mortar stores or e-Commerce companies,
- h) cold storage and warehousing services,
- canteens/restaurants on the premise of the permitted establishments catering to only inhouse staff/residents may remain functional,
- j) all industries/factories and related activities,
- k) all constructions and related activities, including repairs,
- I) agricultural and related activities,
- m) offices of Central and State Government offices, their attach and subordinate offices, PSUs, local bodies, and related activities, Courts and their related activities, functioning of airport and railways and related activities,
- n) Public utilities (including petroleum, CNG, LPG, PNG), power generation, and transmission units, post and courier offices, water sanitation and related activities, including vehicles repairs, hardware shops, etc.,
- o) hotels and hospitality sector, for inhouse guests/residents/staff,
- p) the print and electronic media, and related activities,
- q) telecommunication and internet services, and related activities,

- r) LPG cylinder services;
- 4. The following advisory is issued for strict compliances:
 - a) All non-government employers are advised to actively plan for and promote work from home for the employees working in their shops/establishments/factories and physical presence should be sought only if essential,
 - b) All employers should enforce staggered timings for arrival and appropriate departure of their employees, and all covid behaviour/norms should be enforced at the workplaces,
 - c) All employers are advised to ensure that employees with symptoms, like cough, cold, fever, or if they are short of breath, etc., are to remain home and take appropriate medical care,
 - d) Crowding in lifts, staircases, corridors, common areas including refreshment kiosk and parking areas is to be strictly avoided,
 - e) Divyangs and parents with children having special needs are advised to work from home.

Additional restrictions imposed in Covid Containment Zones shall remain in force.

Any person contravening this order shall be punishable under Section 188 of the Indian Penal Code and Section 51 to 60 of the Disaster Management Act, 2005

ORDER

Sub:- SOP on preventive measures to contain spread of COVID-19 in the State of Goa for domestic Air travel & Railways.

WHEREAS, in view of spread of COVID-19 due to the increasing cases of Covid-19 in other States of India and the likely risk to public health and safety, the State Executive Committee has adopted the following Standard Operating Procedures (SOP) for persons travelling to Goa by Air & Trains with effect from 25.11.2020 for strict implementation:-

- a. In the emergent scenario of new wave of Covid-19 in many States, all the incoming passengers at the airport and the railway stations within Goa will be subjected to compulsory thermal scanning.
- b. Only those who pass through such screening may go home/to their destination. Passengers with body temperature beyond acceptable range will be sent for Covid test on payment basis (Rs. 2000/- per individual). Further course of action will be as per the prescribed protocol of Health Department.
- c. Persons travelling from Goa to Maharashtra by Road, Railway and Air and who are desirous to obtain RT-PCR negative test report from the Health Authorities may do so after paying Rs. 2,000/- (Rupees Two Thousand Only)with reference to Order and SOP issued by Maharashtra Government dated 23.11.2020. Further, passengers who willingly opt for Covid test on the arrival at the airport and railway station in Goa shall pay Rs. 2,000/-(Rupees Two Thousand Only).
- d. The procedure of issuing receipts and conducting tests shall be followed as per the SOP issued earlier in this regard.

NOW THEREFORE, all concerned Deputy Collector & SDOs of North Goa District are hereby directed to adhere to the above guidelines.

This comes into force with effect from 25/11/2020.
